Subject:-Implementation of 6th CPC grant of PB.II with i'rs. 5400 as grade
pay after completion of 4 years of service in the pre-revised pay
scale with grade pay of Rs. 4800/-.

Sir,

This is in continuation of this office letter No. No. 28-7/2006-C/6th
CPC-5459 dated 18.09.2008 on the subject cited above and to say that
number of references have been received to clarify the implementation of
CHQ orders for grant of PB.II with grade Pay of Rs. 5400/- after completion
of 4 years of regular service in the pre-revised pay scale with grade pay of
Rs. 4800/-.

In this connection it is clarified that all those officers (7 categories)
mentioned in the CHQ letter dated 18.09.2008 in the pre-revised pay scale
of Rs. 7500-12000 may be placed in the revised pay structure of PB.II i.e.
9300-34800 with grade pay of Rs. 5400 after completion of 4 years of
regular service in the pre-revised scale in the grade of Rs. 7500-12000/- on
functional post on or after 01.01.2006.

However all the officers who are working in pre-revised pay scale of Rs. 7500-12000/ on Adhoc basis will be placed in revised pay band of PB-II in the pay scale of Rs. 9300-34800/- with grade pay of Rs. 4800/-.

Besides, above the pre-revised pay scale of Rs. 5000-8000, 5500-9000 may be treated as merger in the pay scale of Rs. 6500-10500.

Accordingly the pay may be fixed in the replacement pay band.

It is once again emphasized that all the H.O.s./ DDOs should ensure that the revised pay/pension is fixed and paid strictly in accordance with the circulars issued by the Ministry of Finance/CHQ and in no case any over payment should be made. However an undertaking to this effect that over payment if any made will be recovered from individual officer/officials should be obtained before making payment of revised pay/arrears of revised pays.

This issues with the approval of the Competent Authority.
