ORDER

Pursuant to implementation of various Court Orders, Non-Functional Upgradation (NFU) in Grade Pay of Rs. 5400/- in PB-2 has been granted only to those Assistant Engineers of sub-ordinate Engineering Cadre, who were applicants to various Court Cases and who have completed four years of regular service as Assistant Engineer in Grade Pay of Rs. 4800/- in PB-2.

- 2. Now Ministry of I&B, in consultation with D/o Expenditure, has conveyed their approval, vide order No. 515/53/2016-BA(E) dated 15/11/2017, to grant Non-Functional Up-gradation (NFU) in Grade Pay of Rs. 5400/- in PB-2 to all similarly placed Assistant Engineers of Sub-ordinate Engineering Cadre of AIR & Doordarshan, who have completed four years of regular service as Assistant Engineer in Grade Pay of Rs. 4800/- in PB-2.
- 3. Pursuant to the said approval of competent authority, all Assistant Engineers shall be granted Grade Pay of Rs. 5400/- in PB-2 on Non-Functional basis, which is not linked to vacancy and shall be given retrospectively w.e.f. 1/1/2006 or on completion of 4 years of regular service in the Assistant Engineer grade in Grade Pay of Rs. 4800/-, whichever is later, provided they are clear from vigilance angle.
- 4. This issues with the approval of the Ministry of I&B and D/o Expenditure, Ministry of Finance.
