Subject: Grant of Non-Functional Grade Pay(NFGP) of Rs.5400/- in PB-2 to Senior Administrative Officer & IA-clarification reg.

I am directed to say that references have been received in this Directorate from some AIR & DDK offices seeking clarifications with reference to this Directorate's order No.33/2015-S-II dated 23.06.15 for grant of NFGP to eligible officers. The said order of Directorate provides that Sr.A.Os. & IAs of AIR&DD having completed 4 years of regular service in the pre-revised pay scale of Rs.7500-12000 as on 01.01.06 or on the date on which they complete 4 years of regular service in the pay scale of Rs.7500-12000/Grade Pay Rs.4800/- may be placed in the NFGP of Rs.5400/- in PB 2 w.e.f. 01.01.06 or from the date on which they complete 4 years of regular service in Grade Pay of Rs.4800/-.

- 2. The matter has been examined in this Directorate in the light of various instructions issued by DOPT. This case is similar to grant of NFU to SOs of CSS/PS of CSSS and also AE of subordinate Engg. Cadre of AIR&DD. In both the cases, the NFU is granted subject to vigilance clearance. Taking all aspects into consideration, it is inferred that the same principles may also be extended while granting NFGP to Sr.A.O./IA. Accordingly, it has been decided that grant of NFGP to Sr.A.O./IA, as conveyed vide this Directorate's order dated 23.06.15, would be subject to vigilance clearance.
- Therefore, while granting NFGP of Rs.5400/- to eligible Sr. AOs/IAs who have completed 4 years of regular service in GP of Rs.4800/- vigilance clearance may be obtained invariably.

4. All Zonal Heads/HOOs-AIR/DD are requested to take necessary action prior to sanction of NFGP to Sr.A.Os/IAs.
