**OFFICE MEMORANDUM**

Subject:-Revision of pre-2016 pension cases-regarding.

The undersigned is directed to say that orders for revision of pension of pre-2016 pensioners/ family pensioners by notional pay fixation in the 07<sup>th</sup> Central Pay Commission Matrix have been issued vide DOP&T O. M. No. 38/37/2016-P&PW (A) dated 12.05.2017. Subsequently, concordance tables for fixation of revised pay and pension/ family pension of pre-2016 pensioners/ family pensioners have also been issued vide DOP&T O. M. No. 38/37/2016-P&PW (A) dated 06.07.2016 and 18.07.2017.

2. The responsibility has been cast on Heads of Department and Pay and Accounts Office attached to the office from which the Government servant has retired or was working last before his death to revise the pension/ family pension of pre-2016 pensioners/ family pensioners with effect from 01.01.2016. Further, it has also been brought out that no formal application is to be sought from the pensioners/ family pensioners for revision of pension/ family pension. The Head of Department & Pay & Accounts Office attached to this offices should suo moto proceed to process the revision cases immediately to avoid delays in issuance of revised PPOs of pre-2016 retirees.

3. However, Ministry of Information and Broadcasting have pointed out that the progress of revision of pension cases of pre-2016 retirees is extremely slow and dismal. As the matter has been flagged by CCA during the weekly Review Meeting chaired by Secretary (I&B), it has been directed to expedite the revision of pension cases of pre-2016 retirees on Priority and a progress report is to be submitted to the Ministry on a weekly basis. It has been further directed by the Ministry to complete the exercise of revision of pension of all pensioners by 31.08.2017.

4. In view of the above, all Head of Offices/ DDOs are requested to expedite the revision of all pre-2016 pension cases originating at their end and send the pension revision calculation sheet to the respective PAOs to enable them to process further and issue revised Pension Payment Order (PPO) to the CPAO/ pensioners respectively. It should be ensured that this exercise is completed before 31.08.2017 to avoid any criticism by Ministry of I&B/ Prasar Bharati.

5. The **Action Taken Report** i. e. the status of revised cases in the enclosed proforma may be sent to this Directorate **latest by 24<sup>th</sup> August, 2017** without fail. It should be ensured that the gap between column (A) and (B) of the proforma is reported zero; i. e. all the cases requiring revision should be reviewed by reporting date.
