Dear Smt. Kaur

Kindly refer to this Directorate's letter of even number dated 02.01.2014 and subsequent reminders dated 16.01.2014, 31.01.2014, 05.02.2014, 17.02.2014 & 10.03.2014 seeking MIB's advice/directions to grant ACP benefits in the light of the Judgment dated 07.09.2009 in O.A. No.514/2002 read with Judgment dated 23.05.2012 in CCPA No.22/2011 passed by Hon'ble CAT, Patna Bench in respect of Sr. Engineering Assistant and Assistant Engineer.

In this connection it is submitted that in the judgment of Review Petition No.141 of 2012 filed before Hon'ble High Court Patna it is interalia mentioned that the petitioner seek to withdraw the present Review Petition to file Writ Petition before appropriate court of law. Thereafter Ministry of I&B was requested to furnish advice/directions as to whether the judgment of CAT, Patna, Bench should be challenged by way of fresh writ petition in Patna High Court or ACP benefit as per the court judgment should be extended to all similarly placed officers. The directions/advice from Ministry of I&B is still awaited.

This Directorate is receiving a lot of representations/court cases in this regard. The representatives of various Unions of All India Radio & Doordarshan Engineering staff met the Director General, All India Radio and expressed their disappointment and anguish over the delay in settling the issue.


