Minutes of the Meeting of the Screening Committee held on 15/06/2012 at 03:00 p.m. in the Chamber of Joint Secretary (Broadcasting), Room No. 660, 'A' Wing, Shastri Bhawan, New Delhi with the following composition:

Proposal: To consider suitability of Sh. Praveen Kumar, EA applicant in OA No. 477/2011 filed in CAT, PB, New Delhi for grant ACP benefit in accordance with the order of CAT Patna in OA No.514/2002 and the order dated 25.8.2010 of High Court of Patna in CWJC No.6451/2007.


- The Screening Committee was informed that Sh. Praveen Kumar filed O.A. No. 477/2011 with the prayer to grant the benefits of ACP w.e.f. 20.2.2008 extending the benefits of Order dated 7.9.2009 in O.A. No. 514/2002 passed by CAT, Patna Bench. At the admission stage itself, the CAT, Principal Bench, New Delhi disposed of the petition directing the respondents to consider the applicant's pending representation and treat the O.A. as supplementary representation and analyse whether the case of the Applicant is squarely covered by the judgment of Patna Bench of this Tribunal, as stated within and if the case is found to be fully covered, the benefits applicable to the Applicants in the said OA should also be extended to the Applicant in the present OA. If it is not covered squarely, a speaking and reasoned order needs to be passed with a copy to the Applicant. The above exercise should be completed within a period of 9 weeks from the date of receipt of a certified copy of this order.
- The Screening Committee was informed that in pursuance of the order passed by CAT PB, New Delhi in O.A. No. 477/2011 and the speaking order dated 24/02/2011 passed by DG:AIR, the third meeting of the committee has been convened to consider the case of Shri Praveen Kumar, EA for extending similar benefits as was extended to the applicants in OA No 514/2002 in CAT, Patna. The Service Book, CR Dossiers and the vigilance clearance in respect of Sh. Praveen Kumar forwarded by DG:AIR were placed before the Committee.





Praveen Kumar, EA, FIT for grant of ACP benefit and therefore decided to grant ACP in the pre-revised scale of Rs.8000-13,500 benefit to Sh. Praveen Kumar, EA w.e.f . 20.02.2008 subject to the outcome of Civil Review no. 141/2012 filed in High Court of Patna and any other legal proceedings to be initiated.
