SHRI V. AJAY KUMAR, MEMBER (J) :

Heard learned counsel for the applicants.

MA No.3511 OF 2014

This MA filed by the applicants for joining together is allowed.

OA No.4028 OF 2014

The applicants have filed this OA seeking the following reliefs and interim relief:

Main reliefs:-

“ (i) That the Hon’ble Tribunal may graciously be pleased to pass an order declaring to the effect that the whole action of the respondents not considering and not extending the benefit of judgment dated 07.09.2009 passed by the Hon’ble Patna Bench in OA No.514/2002 is totally illegal, arbitrary and discriminatory and consequently, pass an order directing the respondents to consider the case of the applicants for granting first financial up-gradation under ACP Scheme on completion of 12 years of service in the grade of Rs.8000-13,500/- from due date and granting 2nd financial up-gradation on completion of 24 years of service in the pay scale of Rs.10000-15200 from due date with all consequential benefits including the fixation of pay and arrears of difference of pay and allowances with interest, by way of extending the benefit of judgment dated 07.09.2009 passed by Hon’ble Patna Bench in OA No.514/2002.

(ii) Any other relief which the Hon’ble Tribunal deem fit and proper may also be granted to the applicants.”

Interim Relief:

“During the pendency of the OA, the Hon’ble Tribunal may graciously be pleased to pass an order directing the respondents to consider the pending representation of the applicants for the prayed relief by passing a speaking and reasoned order.”

2. It is submitted by the learned counsel for the applicants that the applicants have made number of representations vide Annexure A/1 (Colly). However, the respondents have not yet considered the aforesaid representations.

3. In the facts and circumstances of the case, we dispose of this OA at the admission stage with the directions to the respondents to consider the aforementioned representations of the applicants and pass appropriate speaking and reasoned order thereon within a period of 90 days from the date of receipt of a certified copy of this order. There shall be no order as to costs.
