

Subject:- CCP No. 22/2011 in O.A. No. 514/2002 filed by Akashvani & Doordarshan Diploma Engg. Association & Others Vs. UOI & Others before Hon'ble CAT, Patna regarding grant of ACP.

This is in continuation to this Directorate's letter of even number dated 29.06.2011 on the subject noted above. As already stated, the Ministry of I&B has in consultation with DOP&T, Department of Expenditure and Department of Legal Affairs given its approval for the implementation of CAT's order dated 07.09.2009 passed in O.A.514/2002 in favour of the applicants. Accordingly, the Station is directed to issue necessary orders in respect of the applicants as per Hon'ble CAT's orders dated 07.09.2009 after ensuring that the beneficiary of this approval shall be only those employee who have not opted for the upgraded Prasar Bharati pay scale. While implementing the order, the observations recorded by DOP&T, Department of Expenditure and Department of Legal Affairs as sent earlier may also be kept in view. To ensure the above, an *undertaking* in this regard may be taken by the station from the beneficiaries as per draft enclosed and last salary drawn certificate is also to be annexed with it duly authenticated by the Head of the Station.
