affirming the order of the learned Tribunal observed that the Tribunal should not have issued a general direction to cover cases of all the individuals because under the ACP scheme cases of individuals require consideration. The order of Division Bench was unsuccessfully challenged before the Hon'ble Apex Court.

The petitioners submit that the learned Tribunal has passed order dated 8.12.2011 in CCPA No.22 of 2011 purported to be in terms of order of Division Bench.

The petitioners in fact have tried to question the validity of the said order and being conscious about the limitation in challenging the order dated 8.12.2011 passed in CCPA no.22 of 2011 in Review Application, seek to withdraw this Review application to challenge the same before an appropriate authority.

This review application is accordingly dismissed as withdrawn.
