**ORDER**

Shri R.K. Jain, Assistant Engineer, DG:Doordarshan and others had filed O.A. No. 2662/2009 before Hon'ble CAT, PB, New Delhi claiming therein grade pay of Rs.5400/- in pay band-II.

In pursuance of CAT's order in said O.A. it has been decided to grant Grade Pay of Rs.5400/- in PB-2 on non-functional basis to the applicants after having put in 4 years of regular service in the grade pay of Rs.4800/- in PB-2 subject to outcome of the Review Petition filed by the Department.

It is clarified that grant of the higher grade pay of Rs.5400/- in PB-2 on non-functional basis is not linked to vacancy and may be given retrospectively w.e.f. 1/1/2006 provided the applicants have;

- (i) Completed minimum 4 years of regular service as on 1/1/2006 as Assistant Engineer &
- (ii) is clear from vigilance angle.

Applicants who have not completed 4 years regular service as Assistant Engineers shall be entitled to this pay scale immediately on completion of 4 years regular service in the AE cadre provided they are cleared from vigilance angle.

It is further clarified that the non functional Grade Pay of Rs.5400/- in PB-2 will not be granted to such of those Group 'B' officers who have got the Grade Pay of Rs.4800/- on upgradation under the modified assured career progression scheme.

Sir,

I am directed to refer to the order dated 30-09-2011 passed by the Hon'ble CAT, Principal Bench, New Delhi in Contempt Petition No. 667/2011 in OA No. 2662/2009 filed by Sh. R.K.Jain and others directing DG:Doordarshan to comply with the Hon'ble Tribunal's order dated 06-08-2010 in OA No. 2662/2009 directing the respondents to grant Grade Pay of Rs. 5400/- in PB-2 after completion of four years regular service in Grade Pay of Rs. 4800/- with all arrears, without any fail subject to the outcome of the Writ Petition, the respondents propose to file before the Delhi High Court and to inform that, pending a decision on the Review Application in the OA already filed before the Hon'ble Tribunal, it has been decided with the approval of Ministry of Finance (Department of Expenditure) to implement the impugned order dated 06-08-2010 referred to above, as far as it relates to the four applicants in the OA, subject to the outcome of the Review Petition already filed in CAT, PB, New Delhi or the Writ Petition to be filed in Delhi High Court or SLP in the Supreme Court, if necessary.

2. DG:Doordarshan is accordingly requested to take further necessary action in the matter under intimation to this Ministry.
