## Subject: - Clarification requested by PAO, Lucknow in respect of service of Helper – Regd.

Please find AIR Lucknow's Letter No. PAO/AIR/LKO/PENSION/2021-22/573 dated 24.06.2022 on the subject mentioned above. (Copy enclosed)

2. Clarification for the queries raised by Pay and Accounts office, Lucknow is as below,

SI. No.	Clarification Sought	Reply
1	after 1990 onwards and subsequently	<ul> <li>(i)Helpers joined prior to 1990 and after 1990 are of same category i.e. Employees on Deemed Deputation and no difference till joined on or before 5.10.2007.</li> <li>(ii) As per Recruitment Rules notified on 15.02.1995, the method of Recruitment to the post Technician is 80% by direct recruitment and 20% by promotion. Promotion eligibility condition is Helpers working in All India Radio and Doordarshan.</li> <li>(a) who have completed 11 years of service as Helper on the 1<sup>st</sup> July of the year and</li> <li>(b) Helpers who have passed the Departmental Competitive Examination with 50% minimum marks in each paper.</li> </ul>
	Should be treated as promotion or fresh appointment to the post of Technician.	(iii)Hence, in respect of Helpers promoted under 20% promotion quota mentioned above through Departmental Examination, it is to be treated as promotion. In case of Helpers appointed as Technician under 80% direct recruitment quota it is to be treated as fresh appointment.

	How the services of these cases should be considered prior to Technician for the following purpose	C
2	a) Counting of Service of helper for the purpose of further	Point 1(iii) clarifies this position. For promotion from Helper to Technician, service of Helper will be counted if promotion is under 20% quota through Departmental Examination. However, for further promotion from Technician to Senior Technician, the service of Helper is irrelevant as it is not a feeder grade post.
	b) Counting of service of helper for the purpose of ACP/MACP or not	<ul> <li>Refer reply 1 above.</li> <li>(i) For ACP/MACP, Service of helper will be counted for Helpers who were promoted under 20 % promotion quota through Departmental Examination.</li> <li>(ii)For ACP/MACP, Service of helper will not be counted for Helpers who were appointed under 80 % direct recruitment quota, as it will be a fresh appointment from a lower pay scale.</li> </ul>
	c) Counting of service of helper for the purpose of Pension or not.	For the purpose of Pension, the service of helper will be counted for those appointed by (i) Departmental Exam and (ii) Direct Recruitment subject to the condition that the Helpers has applied through the proper channel. However the qualifying service would be further subject to extant pension rules applicable.

  - a) Counting of Service of helper for the purpose of further promotion or not.
  - b) Counting of Service of helper for the purpose of ACP/MACP or not
  - c) Counting of Service of helper for the purpose of Pension or not.

You are requested to provide the clarification on above mentioned points at the earliest for the expeditious settlement of pension cases received in this office.
