Approval of the Ministry of Finance (MoF), Department of Expenditure is hereby conveyed vide its U.O. No. 22(1)/E.IIIB/2020 dated 12.09.2022 for the merger of the posts of Sr. Technician, Technician, Mast Technician and Diesel Technician in the Subordinate engineering cadre of AIR and Doordarshan in the 6th CPC pay scale of PB - 2 + GP Rs.4200 GP into a single cadre prospectively with effect from the date of notification of Recruitment Rules (RRs) subject to the following conditions:-

- I. (i) It does not involve any change in the pay scale in any manner whatsoever,  
(ii) It does not require re-fixation of pay nor does it involve change in date of increment.  
(iii) it does not disturb the next higher post in the hierarchical line of promotion  
and  
(iv) It does not entail any financial implication whatsoever in any form whatsoever.
  - II. The aforesaid merger will be applicable only for the Government servants on deemed deputation to Prasar Bharati who joined on or before 05.10.2007. The post will be re-designated as "**Senior Broadcast Technician**" as recommended by the Cadre Review Committee constituted by Prasar Bharati for restructuring of Engineering Cadre.
  - III. The revised post-merger sanctioned strength of the single cadre is to be decided taking into progressively reducing sanctioned strength of dying cadre of "Mast Technician" etc.
2. Instructions contained in DoPT OM No. 35034/3/2008-Estt(D) dated 19.05.2009 and DoPT OM No. 35034/3/2015-Estt(D) dated 22.10.2019 with respect to Merger of Pay Scales/Posts may be followed.
3. The redesignation of the merged post as "**Senior Broadcast Technician**" as recommended by the Cadre Review Committee constituted by Prasar Bharati may be confirmed.

4. In view of the above, Prasar Bharati is accordingly requested to forward the Draft Recruitment Rules(RRs) to this Ministry for the merged posts in the prescribed format immediately for further necessary action.
