ORDER


Reference this Directorate's order No.3/17/2009-S-IV(A)/Vol.II/511 dated 14.10.2014 and No.S/10/2014-S-IV(A) dated 23.10.2015 regarding grant of upgraded pay scale of Rs.6500-10,500/- to Engineering Assistants who joined service between 25.02.1999 to 05.10.2007.

2. In continuation of the above said orders, approval of the Competent Authority is hereby conveyed to grant the upgraded pay scale of Rs.6500-10,500/- to all remaining similarly placed Engineering Assistants who joined service between 25.02.1999 to 05.10.2007 and who have not gone to any court or have not recently filed any court cases, with effect from their date of joining with consequential benefits.

3. The Engineering Assistants who were appointed during the period between 25.02.1999 to 05.10.2007 and have left the organization as per rules/procedure and through proper Channel are also entitled to the above said benefit.

4. It has also been decided by the Competent Authority that the upgraded pay scale of Rs.6500-10,500/- shall be counted as an upgradation against the three upgradations admissible under the MACP Scheme subject to the outcome of WP No.2034/2017 filed in the matter by DG:AIR Vs. Smt. Shyamali Biswas in Hon'ble High Court of Delhi.
