Subject:- One pay scale for one cadre in the light of dismissal of review petition No.2623/2011 in SLP (C) No.99/2011 filed by the Ministry of I&B in the Supreme Court – CP in OA No.1743/2004 filed by Shri Mahender Singh Rana, EA.

2. In this connection, it is stated that the response of the Ministry in the matter is still awaited and the prescribed time limit given by the Hon'ble Court of Law is going to expire. It is also stated that Notice of CAT, PB, New Delhi with next date of hearing 31.03.2014 received through the PB Sectt. in M.A. Nos. 680 & 563 of 2014 in Contempt Petition Nos. 499 & 494 of 2011 arising out of O. A. No. 1743 & 1742 of 2004 filed by Sh. Mahendra Singh Rana & Sh. Ananda Kumar A. A. respectively before Hon'ble CAT, PB New Delhi has been forwarded to DG:DDn on 24.3.2014 with request to defend the case (Copy enclosed), since the matter was been defended by the DG:Doordarshan (DDK, Delhi).

3. In the meantime, a representation also received from Sh. Mahendra Singh Rana through PB Sectt. is being forwarded herewith for consideration/advice.

4. Kind attention of the Ministry is also invited towards the applicability to the condition stipulated in para 2(i) of the Ministry of I&B order dated 25.2.1999 in case, it is decided to extend the benefit of said upgraded pay scales to the petitioners.

5. It is submitted that the stipulated time for implementation of the aforesaid judgements to be implemented within three months w.e.f. 09.01.2014 is going to expire very shortly. It

is, therefore, requested that decision on the issue may be communicated. If required, it may be advised as to whether an M.A. may be filed before the Hon'ble CAT, PB, New Delhi to grant some more time (i.e. two months) to consider the matter to avoid fresh Contempt proceedings, if any.
