**Subject: Clarification on admissibility of MACP to some categories of staff (Programme & Engineering Cadres) granted upgraded pay scales in pursuance of Ministry of I&B order dated 25.02.1999-reg.**

Please refer to MIB's letter No. 503/05/2014-BA(E) dated 31.01.2018 on the above subject wherein MIB had clarified on admissibility of MACP to eleven categories of employees and had directed to take necessary action in terms of DOPT's OM dated 02.03.2016 on recovery of wrongful/excess payments made to Govt. servants.

2. In pursuance to these instructions, DG:AIR vide their ID NO. 16/2/2018-S.IV(B) dated 25.04.2018, has brought to notice that some of the field offices have started making recoveries on account of excess payment made based on additional upgradation, if any, granted to the employees on and above the permissible three promotions/ACP/MACP. DG:AIR has further stated that such recoveries being made without any specific instructions from them are discriminatory as not all of them have started the process and this has brought in unrest amongst the staff members.

3. In order to bring uniformity across the AIR/Doordarshan network, the DG:AIR wishes to issue instructions to all concerned with 3-4 illustrations which would be indicative as to how the Ministry's order is to be implemented. Accordingly, DG:AIR has requested to allow them to issue instructions to all concerned to put on hold such recoveries pending issuance of a clear cut instructions.

4. In this regard, approval of Competent Authority, Prasar Bharati is conveyed to DG:AIR for issuing appropriate instructions to put recoveries on hold for a period of fifteen days from the issue of this letter during which illustrations may be issued to facilitate implementation of MIB's order dated 31.01.2018 in letter & spirit.
