

**Subject:- Clarification regarding Hon'ble High Court order dated 26.11.2018 in WP No 12524/2018 and order dated 20.07.2018 in OA No 2449/2018 filed by AADEE & Ors Vs UOI & Ors before Hon'ble CAT, PB, New Delhi reg-**

Sir,

I am directed to inform that AADEE, the applicants in Writ Petition No. 12524/2018 has filed Contempt Petition No. 512/2019 before Hon'ble High Court, Delhi aggrieved by non-compliance of Hon'ble Delhi High Court's order dated 26-11-2018 as the PAOs of Delhi, Kolkata, Mumbai and Chennai have issued directions for reducing the pay of petitioners by effecting recoveries despite the orders to maintain *status quo* by Hon'ble High Court, Delhi. In this regard attention is also invited towards correspondence rested with Prasar Bharati's ID No M-1/30/2012-PPC dated 30.01.2019, dated 12-03-2019 and letter No. PB-9(14)/2019-Admn/Pension Cases/63 dated 30-04-2019 and Ministry's replies vide ID Notes dated 27-02-2019 and 03-04-2019 (copies enclosed).

2. It is observed from the contents of the Contempt Petition that despite instructions from Ministry and suggestion made by DG:AIR vide letter dated 28-01-2019 to comply with the orders of Hon'ble High Court in the case, PAOs are still re-fixing the pay of the petitioners alongwith recoveries which has primarily led to the instant contempt.

3. In view of the above, Prasar Bharati is requested to issue the necessary instructions urgently to all the PAOs for maintaining *status quo* in the matter in compliance of Hon'ble High Court Delhi order dated 26-11-2018 in the matter of re-fixation as well as recoveries in the salaries of the affected employees till the final disposal of OA No. 2449/2018 filed by AADEE before CAT, PB, New Delhi.

4. This may be accorded top priority.
